

PowerPoint Template

This template is intended to provide you with draft PowerPoint slides that can be tailored for your specific needs. A PowerPoint presentation is not required for a community meeting, but many meeting leaders find them helpful. The following are a few tips to consider as you edit this template:

- Use the minimum number of slides possible in order to keep the audience's attention.
- Use as few words on slides as possible. Slides with fewer words are easier to view.
- Make sure that you use plain language as much as possible.
- Supplement your PowerPoint with relevant visuals (e.g., maps, photos of the site, photos of the community).
- Avoid jokes or humor, as they could be misinterpreted to mean that ATSDR is not taking the situation seriously.
- Review the points on your slides against the Message Mapping Template, Worksheet, and Checklist to evaluate your messaging before delivery.

Who is ATSDR?

- The Agency for Toxic Substances and Disease Registry (ATSDR) is a federal public health agency based in Atlanta, Georgia.
- Staff in 10 regions around the country





What does ATSDR do?

- ATSDR's main job is to help reduce your exposure to hazardous chemicals.
 - We identify how people in your community might get exposed to chemicals
 - We assess the community's exposure to chemicals and determine if there is a threat to health.
 - We work with the community and many government partners to do this.

ATSDR in your community

ATSDR's Public Health Assessment Process

- Review available environmental data from a site.
- Identify ways people might come in contact with chemicals, such as through water, air, or soil.
- Determine if people are being exposed.
- Determine how that exposure might affect public health.
- Provide conclusions and recommendations.



What happens while the PHA is in progress?

- The PHA usually takes X months (range).
- ATSDR will provide the community with periodic updates on the progress of the PHA through community partners (e.g., X) and social media.
- Once the PHA is completed, we will hold another meeting like this one to present and discuss our findings.
